ANNOUNCEMENT

For those of you who do not know it may be of assistance and interest to provide a brief history of the practices of Hatten Wyatt and of Church Bruce together details of the incorporation of the latter into the former, and the benefits to our mutual clients and objectives which will be realised.

The practice of Hatten Wyatt has undergone significant change over the last 4½ years, when **Jasvinder Singh Gill** acquired the practice from the then former equity partners, namely, Michael Holland, Farook Girach and Anna Turnbull-Walker, becoming its sole proprietor.

The Hatten Wyatt has grown over the years, since its foundation in 1844 by George Sharland. More recently considerable time and effort has been spent in developing the Firm and giving it a recognisable brand. In addition the Firm promoted 3 Salaried Partners to head and oversee their growing departments. Over this period the Firm has invested heavily in upgrading its IT infrastructure, to enable it to operate from more than one site.

Church Bruce was established by Thomas Church in 1936 and over the years has developed into a substantial practice in Gravesend with a well established client base. Colin Crowhurst, Graeme Bentley and Sunita Chauhan

are the current Equity Partners of Church Bruce.

Each Firm whilst providing some services which are similar to those provided by the other, nevertheless has particular niches which the other does not have. The enlarged and combined Firm will cover the widest range of legal work in Gravesend and the surrounding areas.

The expansion does not stop there, as **Damien Jones**, will be joining Hatten Wyatt as a Salaried Partner to head its Private Client Department as of 1st June 2008.

Hatten Wyatt will now operate from 18/21 Wrotham Road,

Gravesend and 51/54 Windmill Street, Gravesend.

The incorporation will be for the benefit of the clients of both Firms, as they will have access to more specialised lawyers.

It should be noted that this is not Hatten Wyatt's first merger with or incorporation of another Practice. In 1969 the Firms of Hatten Winnett & Holland merged with Wyatt & Blackman forming Hatten Wyatt, a significant event at the time which proved beneficial to the Practice and its growing client base.

Jasvinder Gill, the Senior Partner at Hatten Wyatt said *"The incorporation of Church Bruce into Hatten Wyatt, will further strengthen our market position, and enable us to better serve our Clients by combining our resources and expertise. The incorporation will create one of the largest practices in Gravesend and the surrounding areas."*

As of 1st June, the Firm will have 30 fee earners and approximately 70

staff split between the two offices, which are no more than a couple of hundred yards apart.

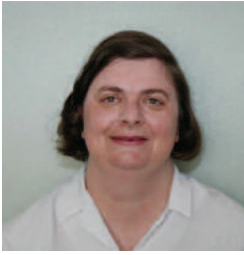
His main practice areas are business services, civil litigation and employment. He is the Partner with overall responsibility for the Firm.
